Subject: Contract: Old Sacramento Security Lighting Improvements

Recommendation:

Adopt a resolution authorizing the City Manager to execute a contract in the amount of \$605,654 with Collins Electric for the installation of boardwalk, balcony, alley, and waterfront lighting in Old Sacramento.

Funds for this project will derive from the City CIP KC96 (Old Sacramento Pedestrian Lighting).

Summary:

This purpose of the Old Sacramento Security Lighting project is to install energy efficient lighting on the boardwalks, balconies, alleys, and waterfront of Old Sacramento to enhance visitor safety through increased and uniform lighting levels. New lighting will also provide a uniform aesthetic to the lighting in Old Sacramento. This report recommends execution of a contract with Collins Electric.

Committee/Commission Action: Staff presented the design to the Old Sacramento Property Owners Committee (OSPOC) for their comments. Comments revolved mainly around the type of fixtures used, and questions were addressed by staff at subsequent meetings.

Background Information:

In January 2004, AEPC Group, LLC was hired by the Convention, Culture and Leisure Department to produce plans for lighting improvements in Old Sacramento. These plans were to include a lighting package for the boardwalks, balconies, alleys, and additional pole-mounted lighting on the waterfront. Implementation of this lighting program also includes the installation of an electrical distribution system to support energy requirements.

Staff consulted with the Police and General Services departments, and the City Historian, on the appropriate type of lighting and material standards and for ease of maintenance.

Construction plans were posted for bid on March 24, 2006 and three responsive bids were received on May 3, as listed below. Collins Electric was the lowest bidder. It is estimated that work will be completed by September.

Financial Considerations:

The proposed contract with Collins Electric is for \$605,654. Construction funding will come from the Old Sacramento Pedestrian Lighting project fund (CIP KC96).

Environmental Considerations:

The Environmental Services Manager has determined that the proposed project is exempt from CEQA under Section Numbers 15301(d) of the CEQA Guidelines.

Policy Considerations:





AUTHORIZATION TO EXECUTE AWARD OF CONSTRUCTION CONTRACT WITH COLLINS ELECTRIC IN THE AMOUNT OF \$605,645 FOR OLD SACRAMENTO SECURITY LIGHTING (KC96)

BACKGROUND

- A. In January 2004, AEPC Group, LLC, was hired by the Convention, Culture and Leisure Department to produce plans for lighting improvements in Old Sacramento.
- B. Construction plans were posted for bid on March 24, 2006 and three responsive bids were received on May 3, 2006. Collins Electric was the lowest bidder.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. Authorize the City Manager to execute a contract in the amount of \$605,654 with Collins Electric, for the installation of boardwalk, balcony, alley, and waterfront lighting in Old Sacramento.
- Section 2. Funds for this project will derive from the City CIP KC96 (Old Sacramento Pedestrian Lighting).
